Registering a Trademark

1. Prior Rights Search

Before registering a trademark, it's advisable to ensure there are no existing conflicts that could lead to infringements or future disputes.

• Basic Search – £200

Conducting a preliminary search across national databases to identify registered trademarks in up to 5 classes. This helps determine the availability of your proposed trademark.

• Comprehensive Search – £250

Includes everything in the Basic Search, plus unregistered/common law searches, company name checks, and searches across international databases. Recommended for broader protection and higher-value trademarks.

Note: While not mandatory, conducting a prior rights search is recommended to minimise the risk of trademark infringements or future disputes. This service does not include trademark registration or addressing opposition proceedings.

2. Trademark Registration – £300 + £25 per class

Drafting and submitting a trademark application to secure legal protection for your brand name, logo, or slogan. This service includes preparing and submitting documentation, monitoring the application process, and providing updates until registration is complete.

Note: Additional fees may apply if objections or oppositions arise during the registration process.

3. Trademark Registration Fees

When registering a trademark in the UK, the Intellectual Property Office (IPO) charges the following fees:

- Application Fee for One Class: £170 (online application)
- Each Additional Class: £50 per class
